- 5. To manage all communications between Unity Theatre and Trusts and Foundations. Oversee the monitoring and evaluation activity ensuring that the needs of funders and external partners are met, including donor reporting, thanking, event invites etc.
- 6. To involve CEO in the process of building relationships with Trusts and

Foundations and exploring networks to help with new approaches.

7. To work collaboratively across Unity
Theatre to maximise opportunities and
networks as well as to help develop robust
fundraising proposals and budgets.
